10,005 movements by 362 different aircraft were recorded in September at an annual rate of \$121k. Most movements were smaller training aircraft and emergency operations. There were 7596 aeroplanes, 1283 helicopters and 1067 ultralights.

Oct 2018

10,355 movements by 354 different aircraft were recorded in October at an annual rate of \$124k. Again, most movements were smaller training aircraft and emergency operations. There were 7445 aeroplanes, 1587 ultralights, and 1117 helicopters.

These have now come into effect and can be accessed on the Department’s website (aviation/environment/airport safeguarding/nasf):</p> <ul style="list-style-type: none">• It is the responsibility of each State and Territory to implement Guideline I into their respective planning systems. While the Guideline informs a consistent approach to



	<p>PSAs at Australian airports, it also allows for some flexibility in how States / Territories choose to adopt PSAs.</p> <p>On 28 September 2018, the Airports Amendment Bill 2018 came into effect, amending the <i>Airports Act 1996</i>.</p> <ul style="list-style-type: none"> • The key amendments relate to: <ul style="list-style-type: none"> ○ a differential Master Plan submission cycle (major airports (Sydney, Melbourne, Brisbane, Perth and new Western Sydney Airport) remain on the current 5 year cycle – other federally leased airports (including Archerfield) will move to an 8 year cycle following their next Master Plan) ○ the mandatory inclusion of a new Australian Noise Exposure Forecast in each new MP ○ an increase to the Major Development Plan (MDP) monetary trigger from \$20 million to \$25 million.

Is Archerfield becoming a playground for the rich?</p> <p>Response by Heather Mattes (AAC) Advised the aircraft is an Albatross Warbird and has been based at AAC for 20 years. The aircraft obtained special permission from the government to fly.</p> <p>Response by Lucas Tisdall (Flight One) Warbird aircraft offer Joy flights to the public for 20 minutes at the cost of \$1,200.
