## **TERMS AND CONDITIONS**

Approved requests are subject to the following conditions: (Refer ERSA Brisbane/Archerfield if applicable)

- (1) This Pavement concession is valid only for the operation(s) specified below and shall not be varied or renewed without the authority of Archerfield Airport Corporation (AAC).
- (2) Aircraft weights **must not** exceed those nominated in the "Max. weight whilst at YBAF" box.
- (3) This concession covers approval from the aspect of pavement strengths and surface characteristics only and may be withdrawn by AAC at any time and on short notice.
- (4) The Archerfield Airport Conditions of Use and Airport User Rules apply at all times.
- (5) Approval of further Pavement Concessions is subjected to no damage occurring following each operation.
- (6) The operator agrees to provide AAC with load sheets indicating the operational weights of the aircraft for all operations conducted at YBAF for the preceding 3 months upon request.
