1	Governance	
1.1	Welcome / Introductions / Apologies Welcome, and introduction from the Chair, gave his work background history of his involvement in handling complaints and dealing with integratory issues and was the first Australia Aircraft Noise Ombudsmen. He emphasised that he is an independent Chair and is also the chairperson for Sunshine Coast & Gold Coast airport community forums. He made clear his motivation for taking on the role as chair of this forum is to	



	contribute to making it a constructive and valuable community engagement forum. - Attendees introduced themselves to the new forum. - Expectations of the meetings to be constructive, productive and make a difference. The Airport will provide information about the airport and engage and coordinate on airport issues. Not all issue will be within control of the Airport e.g. flight paths or noise overhead, the principal control for which is with the tower and Airservices. But there may be opportunities for the airport to have some influence, even in these issues through fly neighbourly agreements. - CASA deals with air safety issues and does not attend these forums, if any CASA issues are raised the Chair will involve them. - The Chair stated that he will be reasonably strict on time, to allow everyone space to contribute. - Minutes will be a summary of the meeting, noting key issues and conclusions, not a record of all conversation. - The meeting is not a decision-making forum on matters of aviation operation, however, there will be decisions such as where the group requires the Chair to write on behalf of the group (to Airservices or the Minister for example) or to formally raise an issue, seek information, or request action from another party. These will be noted in action points. - TOR & code of conduct gives a general guide to the role and the structure. Discussed the current TOR. In the absence of a functioning CACG and Chair, AAC had developed Terms of Reference (TOR). The Airport is very open to feedback on the TOR. Action: Members should submit feedback prior to the next meeting. The TOR will be an agenda item at the next meeting.

3	Archerfield Airport Update		
3.1	PowerPoint display AAC CACG Presentation.pptx Sara introduced herself as the new General Manager of Aviation Operation at Archerfield Airport. Project Arrow Overview & Objectives Realignment of the grass runways is a priority infrastructure development for Archerfield Airport Corporation (AAC) to reconfigure and optimise the secondary crosswind runway facilities, which will cater for current and future general aviation needs, enhance aviation safety, daytime operational flexibility, and unlock key strategic aviation development sites within the airport precinct. Members noted the opportunity if taking off south bound, to adjust and turn left to avoid going over people's houses, If it is possible to miss a lot of the residential areas. This was considered a good suggestion that Airservices will consider. Hangar 101A & B Now completed and confirm LifeFlight will be the new tenant, currently in the process of moving into the hangar. 4.1	PowerPoint display - Airservices YBAF CACG 30 July 2026.pdf Andrea introduced the role of Airservices at airports: - provide navigation services for air space with safety in the air and on the ground the top priority. Airservices includes air traffic control, support services, special projects, community engagement, the Noise Complaints and Information Service. Update on Noise Action Plan For Brisbane Airport Explained the previous packages and are working on Package 4 to optimise the performance of the wider Brisbane airspace system. Discussed the SIDs (Standard Instrument Departure) for Archerfield Airport to reduce airspace complexity and increase the opportunity to use SODPROPS (Simultaneous Opposite Direction Parallel Runway Operations) at Brisbane Airport in peak times to put more traffic over the ocean. Noise Complaints for Archerfield from 01/01/2026-30/06/2026 These are on the website and can be searched with various parameters such as changing locations and date ranges. Complaints/enquiries in the latest report were mainly about Helicopter and emergency flights. Discussion around the current committee members, noting Archerfield Airport related operations are originating from locations outside of the area represented by the current CACG committee. The Chair responded that only one applicant was from outside the area relatively close to Archerfield. Their focus was on Brisbane Airport issues. The airport responded that the focus on inviting others to join the CACG has been to ensure community local to the airport is well represented and the focus will be on Archerfield issues. A member sought clarification on helicopters – emergency flights It was confirmed If they are flying low over houses, they are attending an incident or scene or heading to the hospital. They fly higher up if they are conducting non urgent transport/logistics.	Andrea Lomax
